THE MARKET

ABOUT

The Amqui Station Farmers Market is aptly named due to its historic location. The Amqui Tennessee Passenger Station and Signal Tower was built by and for the Louisville & Nashville Railroad in 1910. Typical of Southern railway station designs found in the region, it featured deeply overhanging eaves supported by triangular knee braces, an agent-operator's office, baggage room, engine room, battery room, second-story signal operator's room, and segregated waiting rooms for passengers.

Johnny Cash frequented the signalmen at Amqui Station throughout the 1970s, acquiring the old train station in 1979. Cash saved it from demolition and relocated the station to Hendersonville, TN. After being relocated to Madison, it has been restored as a museum and educational center. A visitor's center and pavilion were added for special programs and events.

THE AGREEMENT

The Amqui Station Farmers Market runs from April 28 - September 29 from 10 AM until 1 PM.

Vendor Spaces. Vendors will set up on the grass area. Booth spaces are 10' x 10' or 5' x 10' and will be assigned prior to each market. Regular weekly vendors have the same booth location whenever possible.

Market Fees. Booth fees are a minimum of \$20 or 10% of gross sales, up to \$50. Minimum \$20 fee that will be collected at the end of each market day. If you do not show up for a market you committed to, you will be required to pay the previous \$20 booth fee before participating in another market. Booth fees are considered a donation to further the mission of Discover Madison, Inc. - Amqui Station and Visitor's Center.

Taxes. If applicable, the Vendor is responsible for sales tax due to the State of Tennessee. For more information, contact the market manager by email at amquistationfarmersmarket@gmail.com.
